



LIMITED LIFETIME WARRANTY ON WATER TREATMENT SYSTEM

Congratulations, you have purchased the best water treatment system for your property PURE WATER USA warrants to the original owner of the products that the materials of the installed system are free from defects. THE ACKNOWLEDGEMENT OF WARRANTY TERMS SECTION FOR THIS PRODUCT FOUND AT THE END OF THIS DOCUMENT MUST BE COMPLETED, SIGNED AND RETURNED TO PURE WATER USA, BUSINESS ADDRESS (see below), WITHIN (15) DAYS FROM THE DATE OF SIGNING THE CONTRACT TO VALIDATE THE WARRANTY.

POINT OF ENTRY CYLINDER: The Point of Entry Cylinder is warranted for 25 years. PURE WATER USA will replace or repair the mineral tank free of charge, except for handling and transportation costs, provided the owner complies with the conditions outlined in this contract.

- The client must maintain the corresponding salt levels for equipment operation The client must not manipulate the equipment without authorization and supervision of our technicians Scheduled maintenance must be fully complied with every 5 years and the damage must not be attributable to the buyer or due to natural causes not attributable to the company.

CONTROL VALVE: The control valve will have a (25) year limited warranty, PURE WATER USA will replace or repair the valve or its components free of charge during its warranty, except for transportation and labor costs, and that the damage is not attributable to the buyer or to natural causes not attributable to the company.

REVERSE OSMOSIS UNIT: The reverse osmosis unit will have a (25) year warranty. PURE WATER USA will replace or repair its components free of charge during its warranty, except for transportation and labor, provided that the owner complies with the following conditions:

The customer must not manipulate the equipment without authorization or supervision of our technicians Scheduled maintenance must be fully carried out every 18 months That the damage is not attributable to the buyer or due to natural causes not attributable to the company. Replacement filters and membranes are excluded from the warranty, since their cost and replacement must be covered by the original owner.

WARRANTY CONDITIONS: 1. It is a violation of the warranty to replace minerals or replace filters, membranes or any other part of the PURE WATER USA equipment by the owner without prior inspection and supervision by the company. 2. The system must be installed in accordance with county regulations and following the manufacturer's recommendations. 3. A review of our systems will be performed every 18 months by personnel authorized by PURE WATER USA, after calling the customer for a scheduled appointment. 4. Replacement of parts or services by unauthorized personnel will result in the loss of the warranty. 5. The water pressure of the residence or business must be regulated by the buyer, not to exceed 80 PSI. The water temperature must not exceed 100 degrees Fahrenheit. The water supplied by the equipment must not have a chlorine concentration greater than 1 mg/l. A thermal insulator must be installed to protect against damage caused by freezing and the system must be kept isolated from direct sunlight. 6. The system disconnected for more than (6) months will lose the warranty. 7. Claims must be made within (30) days following the incident, presenting the original warranty, under penalty of loss of said warranty.
